IGWA 2015 SPRING FIELD DAY / MUD SCHOOL — Mud Rotary Drilling Utilizing Solids Control —

9:00–9:30 AM: Job Safety Analysis (JSA)

We will teach a detailed job safety analysis. We will walk the job site and discuss potential hazards and preventative measures. Once the job site is clear we will discuss safety hazards on the rig and preventative measures. The goal is to create safety habits that will help prevent accidents.

9:30–10:00 AM: Drill Plan and Solids Control

We will walk the attendees through a drill plan. We will discuss bit selection, tooling, drilling rates, and choice of drilling method. We will discuss a drilling fluids plan that utilizes a solids control unit. We will talk about good drilling fluid properties and how to adjust those properties in specific geologies. Finally, we mix mud and start the rig and solids control. The goal is teach the attendees to utilize a drilling and fluids on every job.

10:00–10:30 AM: Mud Mixing, Mud Testing & Incorporation of Drill Solids

We will slowly drill the first 40 ft. of the hole. Showing the attendees how the solids content of the mud increases with the rate of drilling. We will show basic mud testing and how to correlate the test results to drilling a good well. We will also adjust drilling rates and efficiency of the solids control system. The goal is to show what happens when the system is not operating correctly.

10:30 AM – 11:30 AM: Mud Rotary Drilling to 100 ft. Total Depth

We will demonstrate proper drilling fundamentals in regards to rotation speed and mud pump speed. We will allow the attendees to test mud and monitor the mud properties. The goal is to show the drilling formations changes and discuss how to properly change drilling methods and fluids.

11:30 AM – 12:00 PM Finishing the Hole & Questions/ Wrap-Up

The last 30 minutes will an open discussion of the drilling methods used and issued encountered. We will discuss the importance of removing drill rod at the bottom of the hole without damaging the bottom formations. Finally we will abandon the bore hole with Bentonite Chips. We will show the attendees how to calculate the proper amount of Bentonite Chips and proper installation.

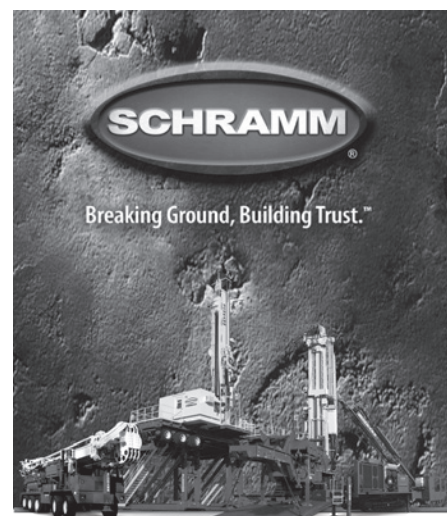

Senate Bill 473 Digest

Voluntary monitoring of water resources. Requires the department of natural resources (department) to establish a program under which volunteers may monitor the water resource (which, as defined in IC 14-25-7, includes both ground water and surface water) and provide monitoring data to the natural resources commission and the department. Provides that the department shall: (1) train the volunteers participating in the program in the proper collection and transmission of data; (2) determine the location and ensure the adequacy of the monitoring wells used in the program; and (3) conduct water resource monitoring independent of the program to verify the quality of the data derived from the program. Requires the department, in selecting the areas in which volunteers will monitor the water resource through the program, to give priority to areas in which temporary failures of nonsignificant ground water withdrawal facilities have been confirmed and areas in which the potential exists for ground water withdrawals to exceed the natural replenishment of the aquifer.

Senate Bill 474 Digest

Analysis of water utility planning and needs. Requires the Indiana finance authority (authority) to prepare an analysis of the planning and long range needs of: (1) the water utilities serving the 15 most populous cities in Indiana; and (2) five other water utilities selected by the authority, each of which serves fewer than 10,000 customers. Authorizes the authority to contract with professionals or with a state educational institution for the performance of some or all of the authority's duties relating to the analysis. Requires the authority to complete the analysis and submit it to the legislative council not later than November 1, 2015. For calendar year 2015, relieves the utility regulatory commission of the duty to submit an annual report concerning water utilities to the legislative council and the interim study committee on energy, utilities, and telecommunications.

Application Deadline: April 30 / Scholarship Awarded: May 30

CRITERIA:

1. Applicant must be a member of IGWA, immediate family of IGWA member, employee of IGWA member or immediate family of employee.
2. Scholarship award can be used at any school of higher education (vocational, technical, community college, or university) for full or part-time attendance. Award can be used towards books, tuition, fees, etc.

REQUIREMENTS:

1. Completed Application Form
2. Statement of 500 words or less describing:
 - a. Proposed use of award money
 - b. Class or school attending
 - c. Future goals
 - d. Information about applicant, such as, but not limited to goals met, accomplishments both personal & academic, etc.
 - e. Financial need/special considerations.
 - f. Transcript of grades, GPA and high school attended

Resumes used for other Scholarship applications will be accepted. However, a Statement of 500 words or less describing the above is required.

Statements & Resumes on separate sheets of paper must be attached to enclosed Statement sheet with signature of applicant.

The award is for one year and is renewable; however, the student must reapply.

SCHOLARSHIP RULES:

Applicant must be a member, immediate family of IGWA member, employee of IGWA member, or immediate family member of employee.

Applicant must be accepted at a college, university or trade or technical school. (Student may be full or part-time)

All applications must be returned before April 30.
Recipients will be notified by May 15.

The IGWA Scholarship Committee has absolute discretion in selecting recipients of the award and in determining the amount of said award. The Committee may make such amendments and modifications of the rules and regulations pertaining to the selection of award recipients, the amount of each award and the payment of awards as they, in their sole discretion, determine.

When an applicant has been named as a recipient of the award he or she shall, prior to August 1 in the year of the award, present to the IGWA satisfactory evidence of his or her acceptance or continued enrollment at a college, university, trade or technical school. Failure to do so will forfeit the scholarship.

The scholarship will be paid directly to the college, university, trade or technical school and will not be paid to the recipient of the award.
