## IGWA's 2020 Convention & Trade Show Continuing Education Units

This program is eligible for 6 continuing education units for Licensed Well Drilling Contractors and 6 continuing education units for Licensed Pump Installers or a total of 12 if you carry both licenses which are due by December 31, 2020!

*Continuing Education for water well drillers and water well pump installers. It's the law.* 

As you know by now, the Indiana General Assembly passed IC 25-39-2-15.5 regarding pump installers license for water wells and continuing education. All pump installers must be licensed and are required to earn 6 hours continuing education units every 2 years. This became effective July 1, 2011. The continuing education offered at this conference will apply to the credit you need by December 31, 2020 for your 2021-2022 recertification.

Reminder this is the end of the 2-year cycle.

Program also approved for CEUs by Illinois.






