



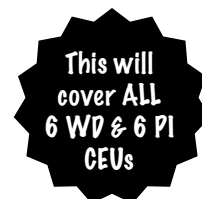

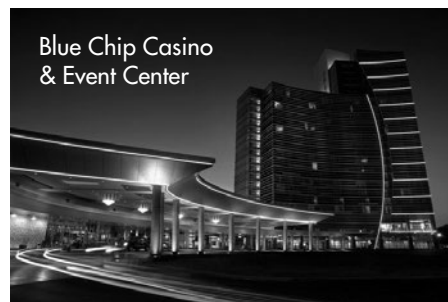

IGWA's 2022 Convention & Trade Show CEUs Approved for Indiana, Illinois, and Ohio

Indiana

This program is eligible for 6 continuing education units for Licensed Well Drilling Contractors and 6 continuing education units for Licensed Pump Installers or a total of 12 if you carry both licenses which are due by December 31, 2022!

Continuing Education for water well drillers and water well pump installers. It's the law.

As you know by now, the Indiana General Assembly passed IC 25-39-2-15.5 regarding pump installers license for water wells and continuing education. All pump installers must be licensed and are required to earn 6 hours continuing education units every 2 years. This became effective July 1, 2011. The continuing education offered at this conference will apply to the credit you need by December 31, 2022 for your 2021-2022 recertification.

Reminder this is the end of the 2-year cycle.

Illinois and Ohio CEU Information

Illinois and Ohio have approved CEU hours for the convention. BUT each state has not approved specific classes. Below is the information for each state. Make sure to follow this information for the proper credits.

Illinois

Illinois has approved the convention for 6 hours however the following classes are NOT approved and cannot be taken for Illinois credit:

- Finance Your Water Well Business, Becca Calkins
- Five Ways to Hire & Retain Talent at Your Ground Water Company, Becca Calkins
- Know Your Drilling Costs, Buddy Sebastian, Sebastian & Sons Drilling, Inc.

You must sign in separately for Illinois credits as well. So if you want Indiana and Illinois credits you will have TWO separate sign in sheets. It is up to **YOU** to tell Jennifer at sign in each day you also need Illinois credit. Credit will not be given after the fact if you did not sign in for Illinois on that day.

Ohio

Ohio has approved the convention for 11 hours of classes however the following class is NOT approved for Ohio:

- IDNR Updates, Mark Basch, IDNR

You must sign in separately for Ohio credits as well. So if you want Indiana and Ohio credits you will have TWO separate sign in sheets. It is up to **YOU** to tell Jennifer at sign in each day you also need Ohio credit. Credit will not be given after the fact if you did not sign in for Ohio on that day.

WATER SYSTEMS COUNCIL'S STATE OF THE U.S. WATER WELL INDUSTRY REPORT

— Executive Summary —

The Water Systems Council is very excited to be bringing you the first-ever State of the U.S. Water Well Industry Report. The report was compiled from our 2021 State of the Water Well Industry survey, where 593 well contractors and 238 "Suppliers", made up of Manufacturers, Distributors, and Manufacturer Representatives participated.

This report will be critical to WSC's mission to promote and protect the future of the water well industry. The report gathers contractor and supplier perspectives on the current challenges, opportunities, and trends within the water well industry. This information will be vital in advocating for the industry at the local, state, and federal levels.

There is much to be gleaned from this report for both contractors and suppliers. This is the first of what will be an annual survey and report so that, going forward, we can more accurately show where we are as an industry, what we need to work on, and identify the opportunities that lay ahead.

The Water Systems Council would like to thank the 831 contractors and suppliers that responded to the survey. We look forward to your continued input for the 2022 survey.

Overview

What a time to be in this industry! With record demand, unprecedented challenges, and an unpredictable world, things look very different today than a couple of years ago.

It is in this environment that The Water Systems Council has embarked on the first annual State of the U.S. Water Well Industry Report. The intent is to give business leaders access to information, benchmark data, and insights that will help them make decisions and capitalize on opportunity. At the same time, this report gives a voice to those in the industry and educates those outside of our industry on who we are and why what we do is so important.

Survey respondents were asked to weigh in on their industry outlook and what's driving it, regulation, environmental factors, technology, investment, and COVID impact. In addition, survey respondents shared information on themselves and their business that presents a clear view of the industry make-up. The insights

derived from diverse industry respondents on a wide range of topics are intended to fuel strategic discussions and facilitate decision-making within your business

The Headlines

- Nationally the average water well contractor has 13 employees and \$1.9M in annual revenue.
- Industry participants are optimistic about the industry, rating their outlook over the next 12 months a 7 out of 10.
- Optimism is driven by home starts, a strong economy, and urban flight.
- Product availability, inflation, and workforce availability are weighing on industry participants.
- Contractors and Suppliers are like-minded regarding the return of normal lead times. Most believe it will be a year or longer.
- The industry, its products, and the services provided have been undervalued for a long time.
- The future of an experienced workforce in the water well industry is threatened by a lack of younger workers joining the industry.
- 68% of respondents rate the impact of regulation on their business as moderate to significant. The specific regulatory challenges vary by region.
- 74% of respondents report an impact on their business from weather-related events. But, often, the effect was balanced (equally positive and negative).
- Contractors indicate an overwhelmingly positive attitude toward adopting new technologies.
- Contractor and supplier investments are aligned. Suppliers are investing in inventory, while contractors are investing in equipment.
- COVID has had an overall positive impact on the industry. Despite the challenges, COVID facilitated events that continue to drive demand.

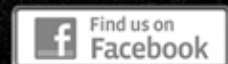

REMINDER OF CEU DEFERRAL BY THE IDNR

All hours are now due to renew your 2023 license. Here is a recap of what the IDNR deferral by the IDNR:

The IDNR had a large number of drillers and pump installers who were not able to acquire the number of hours needed to renew their 2021 license. As a result they chose to DEFER these hour requirements to the 2023 license renewal.

What does this mean for you the driller or pump installer?

1. You acquired all your hours for the 2019/2020 cycle.
 - a. Your hours will stay on the record. You will only need your normal hours for the next cycle of 2021/2022 to renew your 2023 license.
2. You acquired none of your hours for the 2019/2020 cycle.
 - a. You will need DOUBLE the hours for the next cycle of 2021/2022 to renew your 2023 license.
3. You acquired some of your hours for the 2019/2020 cycle.
 - a. You will need to acquire the remaining hours for the

2019/2020 cycle PLUS all the hours for the next cycle of 2021/2022 to renew your 2023 license.

CEU hour requirements:

If you only hold a Well Driller license then you need 6 hours of education each cycle.

If you only hold a Pump Installer license then you need 6 hours of education each cycle.

If you hold a combination Well Driller/Pump Installer license then you need 12 total hours (6 well driller and 6 pump installer).

Most education classes are approved for both well driller and pump installer licenses.

If you have questions about your hours, you need to contact the IDNR. They are the licensing agency and are responsible for tracking your hours. The phone number is 317-232-4160.



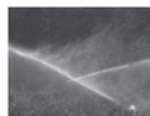
